LOW IMPACT DEVELOPMENT UPDATE

Mason Transit Authority (MTA) has been using the unimproved gravel lot for parking for their rental tenants of the Transit center. The gravel parking lot was a mess of mud puddles and pot holes sending sediment laden stormwater to the storm drain. In the distant past the area was part of the railroad yard and consequently the soils were contaminated. MTA has worked with the Department of Ecology to address the soil contamination on site as part of this project.

SHORE FRIENDLY UPDATE

Shore Friendly Mason has been preparing to present a webinar to educate the community about District services related to marine shorelines, and ways we can work with landowners to help address their shoreline goals while stewarding a healthy Puget Sound. This will be presented by Steve Hagerty and Katrinka Hibler on July 18th, 10 am – 12pm. There are currently 37 participants signed up. The goal is to reach Mason County marine shoreline homeowners that may be interested in working with the District, and to re-invigorate interest in SF program services for the summer and early Fall as we resume delivery of technical assistance and site visits to new landowners.

The Oyster Bay Shoreline Restoration Project is moving forward in the Small Grants Estuary and Salmon Restoration Program (ESRP) process. The presentation to the grant selection committee is scheduled for July 28th.
