## **EPA NEP Forestry Grant Award -**

Informational Agenda Item: The Forestry program will be receiving funding through the coalition proposal from HSIL NEP funding cycle. The program will fund the continuation of forestry services in Mason, Thurston, and Kitsap areas with the potential for serving Jefferson & Pierce as well. Also includes education events, outreach materials, and a small implementation project.

## Wildfire Ready Neighbors DNR Award -

The Forestry program is partnering with DNR for their west-side launch of Wildfire Ready Neighbors (WRN), a call-to-action program for local wildfire preparedness. Funding from the award contracted through the SCC will be used for materials and postage related to outreach and education about wildfire in general and the WRN program. The award will have an effective date of January 20, 2023 with a close of June 30, 2023.
